HOW TO BECOME A SHAREHOLDER

Individual or company – anyone can become a shareholder of the Schaubühne Lindenfels gAG! For either 24, 50, 75, or 240 Euro you receive a share that doubles as a piece of art – given to you by one of the three founding shareholders Anka Liebe, Jörg Schulz, or René Reinhardt. Your purchase supports the Schaubühne and helps us with our work. As a non-profit joint-stock company, our aim is not to generate revenue. Instead, our dividends come in form of culture, independence, and community spirit!

Our shares are literally artistic bonds: several editions of shares, designed by various artists, are limited to either 1000, 250, 100, or 50 prints. Eight editions have been released so far, with motifs by Thomas Moecker, Verena Landau, Christoph Ruckhäberle, Frank-Heinrich Müller, Thadeusz Tischbein and Wolfgang Krause Zwieback.

As shareholder you are eligible to exercise your right to vote in the yearly shareholders' meeting – every share grants one vote. It is the shareholders that, at the yearly assembly, decide on fundamentals of the company, appoint members to the board of directors, determine changes to the by-laws, and hold the board and the CEO accountable.

Your share is bound to your name and will be registered in our share register with your name, date of birth, and adress. It is possible to transfer your share to a third shareholder if you have the approval of the CEO.

You can purchase shares directly here at the Schaubühne in cash to take home with you (please call ahead or write us an e-mail) or by transfering the money to our bank account to then pick up your shares on your next visit to the Schaubühne. If requested, we are also happy to mail the shares to you. You can also buy a share as a present. Just send us the information of the person you are buying the gift for and let us know if we should mail it or you want to pick it up.
